



Terms of use for the Hochseilgarten K 1 GmbH

The security system in our adventure park is tried and tested and is regularly serviced, **but it only works with your help!** If you concentrate and act responsibly with your belaying, you will get to know the fascination of our rope courses. Please follow our signs, safety regulations and terms of use. And make sure your children understand them too. Ignoring our safety regulations and terms of use can be very dangerous, even life-threatening, so following the rules has utmost priority.

- The usage of the Hochseilgarten K1 is at your own risk.
- The instructions of our K1 staff must be followed; they are for your safety.
- The first requirement for climbing on our courses is a healthy physical and mental attitude and constitution. When in doubt, please ask our staff.
- Persons under the influence of alcohol or drugs may not use the Hochseilgarten K1.
- Every participant must take part in our safety briefing.
- During climbing:
 - ✓ Never climb up or down unsecured! **Never unhook both karabiners!**
 - ✓ You must hook the karabiners into the security systems, which are metal with red markings.
 - ✓ Partner-check and four-eyes-principle...that means we look out for each other!
- For safety reasons every participant must wear our safety gear, all of which has been tested and approved. Do not exchange any safety gear.
- Do not smoke when wearing the gear. Smoking is only permitted in the smoking areas. The safety gear must not be taken into this area.
- Please also remove the gear before using the toilet. Let a staff member check your gear after putting it back on.
- All items which could impede movement or fall or cause injuries in any way such as jewellery, piercings, cameras, mobile phones, bottles must be taken off. Long hair must be tied up for your own protection.
- Children under the age of 12 and shorter than 140 cm must be accompanied through the courses by adults. Alternatively you can book additional safety personal in advance. Please ask our staff how many adults you must plan for in your specific case.
- After the safety briefing you have 3 hours to climb in our adventure park. There is no refund of the admission price in case of thunderstorm, storm, fire, etc. or if you wish to stop.

By agreeing to and signing our terms of use you certify that there are no medical reasons that could keep you from taking part in a climbing activity with a high responsibility for your own personal safety. Furthermore you also certify that you have read and understood the terms of use. A legal guardian must sign for a minor. **In case of infringement, the management reserves the right to bar the participant. Further claims remain unaffected.**
